All approved AutoShip orders must be sent to you at the billing address of the credit card (this information will be verified with the credit card company). Any information found to be incorrect may render the AutoShip request to be invalid and will need to be resubmitted.

Any payment not authorized via a credit card or cleared (if a check) will cause the order to be cancelled for that month without notice. Two "not authorized" credit card payments or other payment problems in any twelve month period may terminate this Agreement immediately, without notice. MD's Choice, Inc. is not liable for orders not being shipped to you because of payments being rejected or not authorized, errors, omissions, typographical mistakes, or changes in company policies or procedures.

MD's Choice, Inc. will cancel any AutoShip that is subject to a charge back for any reason, without notice. You agree to pay in full the current balance on your account, if any, at the time of termination.

All products delivered by MD's Choice, Inc. carry a full 30-day money back guarantee. If, for any reason, you do not like the product, simply call our Customer Service Department. We will authorize the refund of your actual purchase price, give you a RMA (Return Merchandise Authorization) number, and either require you to ship the product back to us or destroy the product (at our sole discretion).
